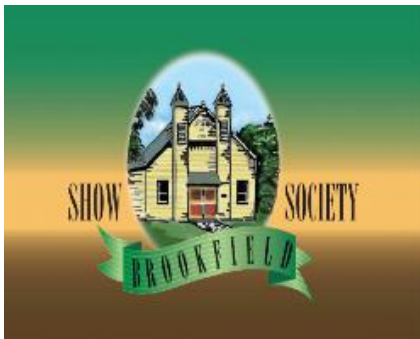

The Stallholder acknowledge and agrees that the Brookfield Show Society Management Committee has the sole right to reject any space rental application or remove the Stallholder from the Brookfield Showgrounds at any time during the Brookfield Show. No reasons for any such rejection or removal needs to be given to the Stallholder.
